Merchant Application

General Information

1. This agreement serves as a contract once accepted. Fees will be refunded should the applicant not be accepted.
2. Vendor accepts all responsibility for local, state and federal taxes and licensing.
3. Vendor is responsible for own insurance. Those without insurance are considered self insured for this event and will indemnify GCRF DBA Mobile Renaissance Fair from all claims.
4. Vendor agrees to wear a medieval / renaissance costume during the entire duration of the event. Shops must have a sign with medieval lettering or rustic appearance.
5. Vendor may set up beginning 8 a.m. to 6 p.m. the day before the fair and must be completely set up by 9 a.m. the day of the fair. There will be no other set up times as this is a highly regulated event.
6. Each person working the booth must fill out a liability form and return it with this agreement to be accepted as a merchant.
7. RV space is limited and must be pre-reserved at an additional \$20 per day
8. Electricity is available and must be pre-reserved at an additional \$60 for 110 volt service.
9. New applicants should include a copy of a photo identification, pictures of the booth set up, pictures of wares, pictures of costumes to be worn.
10. Weapons and other items prohibited by law cannot be sold to minors. A sign must be prominently displayed at the booth that includes wording that weapons will not be sold to minors.

I hereby agree to the conditions outlined above and certify that I carry liability insurance for my merchant business, or that I am self insured. By signing hereby I agree to hold harmless Gulf Coast Renaissance Faire, Inc. from any claims, injuries, accidents or lawsuits that result from my business activities. I further agree that my business is licensed and complies with all local, state and federal laws and that I am solely responsible for collecting, reporting and paying any and all taxes that are due. I further indemnify and hold harmless GCRF, Inc. from all claims in this or any other regard.
